
Expenses for the September 30th presentation of "An Evening With Claudio Arrau" have now been tabulated as follows:

Dear Mr. Attorney General:

I thought you might be interested in knowing that there are social security benefits payable on the basis of the late President's combined record of social security earnings and military service credits. A lump sum of \$177.00 and a maximum family monthly benefit of \$88.60 are payable. The maximum would be reached if claims were filed for the two children. In this way no question would arise concerning the effect of a "widow's benefit" on Mrs. Kennedy's receipt of the \$10,000 yearly Treasury pension payable to Presidential widows.

Dear Tony:

I want to take this opportunity to thank you for agreeing to serve as a trustee of the John Fitzgerald Kennedy Library. Your interest and willingness to help us carry out this project, which meant so much to President Kennedy, are deeply appreciated by all of us.

Efforts on behalf of the Library are proceeding in a number of areas. An 18-member committee of architects and designers from around the world was appointed last week to advise in the development of an architectural program and in the choice of an architect.

Interviews have now begun for a unique and engrossing aspect of the Library, the "oral history" project -- a collection of candid tape-recorded interviews with friends, and with political and international leaders who knew and had dealings with President Kennedy.

Fund-raising efforts so far have resulted in approximately 21,000 contributions, totaling nearly \$4,400,000 of the \$10,000,000 goal. The bulk of these are small gifts from donors all over the country, averaging about \$6. A small number of donors have provided a very large percentage of the total, with individual gifts ranging up to \$250,000. The governments of Puerto Rico and Venezuela have pledged \$100,000 each.

You will be receiving a more detailed summary of activities in behalf of the Library in the near future. In the meantime, however,

I hope you will feel free to give me any thoughts or ideas you might have on how we can work together to make the Library a meaningful living memorial and a significant contribution to the heritage of our country.
